We are committed to protecting your personal information and your right to privacy. Take Capital for Traders is an educational platform. Through our website (the “Site”), we provide access to trading simulations. All trading activity carried out by our customers is simulated or virtual trading only.

## 1. What Information Do We Collect?

**Personal Information You Disclose to Us:** We collect personal information that you voluntarily provide to us when you register on the Website, express interest in our services, or undergo identity verification. This includes: Names, email addresses, phone numbers, mailing addresses, payment information (processed through secure third-party providers), and government-issued ID documents for Know Your Customer (KYC) and Anti-Money Laundering (AML) compliance.

**Information Automatically Collected:** Some information is collected automatically when you visit our Website or use our simulated trading platform. This includes:

- **Device & Connection Data:** IP address, browser type, operating system, and VPN/VPS usage indicators (collected specifically to enforce our geographic restrictions and platform security rules).
- **Trading Data:** We collect and analyze all simulated trading data executed on the platform. This includes order history, execution times, and trading behavior, which is analyzed by our automated Pattern Correlation Systems to prevent prohibited practices (e.g., third-party copy trading).

## 2. How Do We Use Your Information?

We process your information for legitimate business purposes, contract fulfillment, compliance, and security. We use your information to:

- Facilitate account creation and authentication.

- Provide our simulated trading services.
- Enforce our General Terms and Conditions (GTC), including monitoring for prohibited trading practices and IP/VPN evasion.
- Conduct KYC verification and ensure you are not located in a Restricted Jurisdiction or subject to international sanctions (e.g., OFAC, EU, UN).
- Process simulated payouts via cryptocurrency networks.

### 3. Will Your Information Be Shared With Anyone?

We only share information with your consent, to comply with laws, or to fulfill business obligations.

We may share information with:

- **Service Providers:** Payment processors, cryptocurrency payout gateways, KYC/AML verification providers (e.g., Veriff), and cloud hosting services.
- **Risk Management Partners:** Anonymized trading data may be shared with our third-party risk management partners to enforce our trading rules and detect prohibited group-trading patterns.

### 4. How Long Do We Keep Your Information?

We retain your personal information as long as necessary to fulfill the purposes outlined in this notice. Active accounts are retained for the duration of the service. Closed or terminated accounts are retained for up to 5 years to comply with tax, legal, and anti-fraud monitoring requirements.

### 5. Geographical Restrictions

Take Capital for Traders does not provide services to residents of specific regions due to compliance requirements. Services are strictly prohibited in the following regions: Afghanistan, Antarctica, Antigua and Barbuda, Australia, Belarus, Belize, Bhutan, Bouvet Island, Burundi, Cape Verde, Chad, Comoros, Congo, Crimea, Cuba, Djibouti, Dominica, Donetsk, East Timor, Equatorial Guinea, Eritrea, Eswatini, Fiji, Gabon, Gambia, Grenada, Guinea, Guinea-Bissau, Holy See (Vatican), India, Indonesia, Iran, Iraq, Kherson, Kiribati, Kosovo, Kyrgyzstan, Lesotho, Liberia, Luhansk, Malawi, Mali, Marshall Islands, Mauritania, Micronesia, Myanmar, Nauru, Niger, Niue, Papua New Guinea, Russia (Russian Federation), Saint Barthélemy, Saint Lucia, Saint Vincent and the Grenadines, Samoa, San Marino, Sao Tome and Principe, Sevastopol, Seychelles, Sierra Leone, Solomon Islands, Somalia, South Sudan, Sudan, Suriname, Syria, Tajikistan, Tokelau, Tonga, Turkmenistan, Tuvalu, United States of America, Uzbekistan, Vanuatu, Venezuela, Zaporizhzhia.
